

An improved framework

✓ New EAFRD regulation – some major improvements

- ✓ ENRD Leader FG3 recommendations integrated
- Preparatory technical support for cooperation mandatory in all RDPs
- Cooperation with partners in non-rural territories eligible for support
- Approval of projects by competent authorities within 4 months of submission
- ✓ Ongoing application or at least 3x each year
- ✓ Share of common costs eligible
- ✓ Project selection by LAGs possible
- ✓ DG AGRI guidance for implementation of the LEADER Co-operation activities





Tools and guidance

- ✓ DG AGRI guidance for implementation of the LEADER Co-operation activities - translated to all EU languages
- ✓ LAG database & partner search tool
 - Specification completed: designed with DG AGRI and with the other ESI- fund DGs - to be compatible across all funds /DGs
 - \checkmark 'Cooperation offers' document published on ENRD website
 - ✓ Web development of partner search tool underway

- ✓ Based on ENRD LEADER cooperation survey data
- ✓ 47 RDP responses to ENRD survey available / under analysis (as of 8 August 2016) - 20 EU MS featured
- ✓ 10 fiches sent for validation
- ✓ 5 validated fiches
- ✓ Development of fiches ongoing
- ✓ Validated fiches to be published on ENRD website by December 2016

- Practitioner-Led Working Group (PWG) on LEADER Cooperation set up at the ENRD workshop on LEADER cooperation
- ✓ Members: MAs, ENRD CP, DG AGRI, ELARD, LAGs
- ✓ 1st PWG Steering Group meeting held today
- ✓ Major themes
 - ✓ Harmonisation of procedures and rules
 - ✓ Capacity building for Local Action Groups
- Planned key outcome: updated, enhanced EC guidance to cooperation
- Next: LAG ,launch' of PWG at LINC 2016 (Dabas, Hungary) to map challenges from the LAG perspectives / finding LAG members for the PWG
